President Paul Lackner calls meeting to order at 5:30 pm  
Roll Call Paul Lackner, Linda Wagner, Mikale Hudson, Robin Dacuycuy

Linda Wagner reads minutes from last meeting and financial report

Paul talks about 2 special meetings that were held during the month .

1. To establish board members and get new signatures for the bank account
2. To work on agenda for October 4<sup>th</sup> meeting

Paul discusses money still in account to be used.

About \$3500.00 for office and \$24,493.37 for road work.

Road Report:

Mac Castillo has 2 quotes for trailer work. Reports we have about one day left on upper Makoa when dozer comes back. We have not heard from Leonard on when machine will be back. Mac will try to keep contacting him. Work has been done on Kaleponi.

Mac suggest we work on lower middle road and bring gravel back in.

Linda discussed she has talked to the telephone company about their poles being in road easement. They told her they have no money to move poles. We will be getting reflectors to put on them for now. Linda has set up with the power company for someone to come out and look at the tree's in the powerlines.

Mac will work with Hui to move rocks from side of road and fill the holes with gravel and crushed concrete. The rocks are a hazard.

Linda is working with Mac and County for the removal of cars. It will be a slow process but they are doing all that they can to get it done. Caroline will call Linda with another name of someone that removes cars for free.

Donna Delorm mentions that some community members are retaliating against the community because they have been kicked out of the community lot and county lot across from the store.

Discussion, roads is not responsible for people parking on the road. It would need to be a community effort in calling the cops for removal of people blocking roads or partying on the roads.

Mikale has signs and will have them up within a week.

Paul talks about Elections and encourages people to go out and find others to run.

We also need candidates to have their ballots in by Thursday October 6<sup>th</sup> to be put into newsletter.

Paul motions Mikale seconds to bring board members back to 5 from 7. Unanimous

Taxes are done waiting on form that's need to be sent with them per Tonilee.

Liens releases are done need to be notarized and mailed in per Tonilee .

Need to hire someone for mowing along captains drive. Mac suggest we go and clean up side of road before we mow to make it easier on mower. Also the mention of stop signs, cleaning of corners and spraying.

Caroline Frazier offers us to have our meetings at community center. Paul says we have already voted in prior meeting to keep them at Mountain View Elementary. But thanks her. Meetings will stay where they are for now.

Disussed we will keep to our road plan. And will try to get a map for meetings so we know where we have worked and where will be working next.
